## **RULES AND REGULATIONS OF THE „50% OFF TO START” PROMOTION**

### **§1. General provisions**

1. The organiser of the promotion „50% off to start” (Promotion) is Currency One SA (NIP: 7831684097, REGON: 301920555, District Court for Poznań Nowe Miasto and Wilda in Poznań, 8th Commercial Division of the National Court Register under KRS number 0000402723), Street name: Szyperska 14, 61-754 Poznań (Organiser), operator of the Walutomat.pl website enabling currency exchange on the Internet via the platform available at <https://www.walutomat.com/en/>.
2. Capitalised terms used in these Rules and Regulations which have not been defined separately shall have the meaning given to them in the Website Rules and Regulations available at <https://www.walutomat.com/en/terms-and-conditions/>.
3. The promotion is intended for Website Users, i.e.:
  - a. natural persons who are at least 18 years of age and have full legal capacity,
  - b. legal persons,
  - c. organisational units without legal personality but capable of acquiring rights and incurring obligations on their own behalf, which have a Bank Account and have registered on the Website.

### **§2. Promotion rules**

1. The subject of the Promotion is a discount intended for Website Users who meet the criteria and conditions described in § 2 of these Rules and Regulations.
  2. The promotion starts on 30-07-2025 at 00:01 (Promotion start date) and ends on 30-07-2026 at 23:59 (Promotion end date).
  3. Participants in the Promotion may be persons who meet all of the following conditions:
    - a. during the Promotion period, they register a User Account on the Website and, by the start date of the Promotion, they were not Users of the Website, i.e. they did not have an account on the Website as a natural person, legal person or organisational unit without legal personality.
    - b. during the Promotion period, they register a User Account on the Website using the registration form on the dedicated page: <https://www.walutomat.com/en/landing/profit/>
    - c. from the start date of the Promotion, place an order to exchange funds of any single value in any currency that the Website allows to be exchanged.
  4. The Promotion consists in enabling Participants who meet the criteria described in Point 1 of Paragraph 2 of these Rules and Regulations to use the Website's services on

promotional terms, which means that the Website will charge and collect a commission for brokering the first currency exchange transaction (placing an order) after the registration of a User Account on the Website currency exchange transaction (placing an order) in the amount of 50% of the basic commission charged by the Website (which is 0.2% of the value of the executed order).

5. A 50% discount on the basic commission rate for currency exchange transactions carried out on the Website as a result of the first currency exchange order placed by the Participant within 6 months of joining the Promotion. A currency exchange order is considered to have been executed if it has been executed at least in part as a result of matching offers under the terms and conditions set out in the Website Rules and Regulations.
6. Registration on the Website must take place during the promotion period, i.e. from 30-07-2025 at 00:01 to 30-07-2026 at 23:59.
7. In the event of cancellation of the first currency exchange order covered by the discount, each subsequent order shall be executed at the basic commission rate charged by the Website, i.e. 0.2% of the value of the executed order.
8. If the Participant submits more than one exchange order in accordance with the terms and conditions described in point 3c, paragraph 2, the Promotion will apply to the order that is completed first.
9. If, during the Promotion, the User takes advantage of another promotion offered by the Organiser that allows the User's first transaction to be completed on terms more favourable than those specified in point 4, paragraph 2 of these Rules and Regulations, the User's subsequent transaction will be completed on standard terms.

### **§3. Rights and obligations of Participants**

It is the obligation of the Promotion Participant to comply with the provisions of these Rules and Regulations, under pain of exclusion from participation in the Promotion in the event of a breach of the provisions of the Rules and Regulations or other general norms, such as behaviour contrary to applicable law, social and moral norms, socially unacceptable behaviour and behaviour that violates the rules of etiquette.

### **§4. Rights and obligations of the Organiser**

1. The Organiser reserves the right to exclude Participants from participation in the Promotion and, in extreme cases, to block the participation of those Participants who violate the provisions of these Rules and Regulations.
2. In the event of force majeure or other circumstances beyond the Organiser's control, the Organiser reserves the right to extend, shorten, suspend, interrupt or cancel the Promotion. In such a case, the Organiser shall inform the Participants of the reasons for the changes and propose another form of promotion which shall not worsen the existing

conditions of participation, and in particular shall not offer prizes of a lower value or quality than originally promised.

3. The Promotion Organiser shall not be liable for:

- a. any technical problems, in particular those related to the operation of Internet service providers, which could affect the fulfilment of the conditions of participation in the Promotion,
- b. internet connections, in particular for the interruption, suspension or distortion of such connections that may result in the loss or destruction of content sent electronically,
- c. any problems resulting from the operation of banking websites,
- d. damage that may occur to the Participants' computer systems in connection with interactions with banking websites.

## **§5. Personal data**

1. The Data Controller is Currency One SA (NIP: 7831684097, REGON: 301920555, District Court for Poznań Nowe Miasto andi Wilda in Poznań, 8th Commercial Division of the National Court Register under KRS number 0000402723, Street name: Szyperska 14, 61-754 Poznań.
2. The scope of data processed as part of the promotion is equal to the scope of data processed under the standard terms and conditions of service.
3. Personal data within the Promotion will be processed in connection with the User's participation in the Promotion and the conduct of any complaint process.
4. The processing of personal data is carried out in accordance with the provisions of law, in particular with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation). ## **§ 6. Complaints procedure**

1. Each Participant has the right to lodge a complaint regarding any non-compliance of the Promotion with these Rules and Regulations.

3. Complaints sent by email to [kontakt@walutomat.pl](mailto:kontakt@walutomat.pl) and in writing to the Organiser's registered office should be submitted with the note „50% off to start”.
4. In the event of a negative decision on the complaint, the Participant may bring an action before the competent court of general jurisdiction.
5. A Participant who is a Consumer may use extrajudicial means of complaint and redress before the Permanent Consumer Arbitration Court at the competent Provincial Inspectorate of Trade Inspection.
